FINAL(?) CHAPTER OF THE SAGA OF THE NAVAL SEALS

Earlier newsletters outlined the story that, back in 2004, four Americans were captured in Fallujah, Iraq, and their bodies mutilated. After their corpses were dragged through the streets, two of them were left hanging from a bridge over the Euphrates River for all the world to see. One of those murdered was a former Navy SEAL.

For many years, the SEALS tracked the ringleader of these atrocities, Ahmed Abed. A few months ago, the SEALS finally captured Ahmed Abed and brought him back alive. Upon being interviewed, however, Ahmed Abed told investigators he had been punched by his captors and had a bloody lip to show for it. Three of the SEALS were then charged with assault. All three refused to submit to non-judicial punishment or "captains mast" which is generally viewed as admitting guilt and, therefore, were arraigned on criminal charges. A number of Post 46 members became very interested in this story even to the point of writing letters to those people who might have some influence in the outcome.

The good news is that all three SEALS have since been found "not guilty" of these charges. Huertas and Keefe were acquitted by trials in Baghdad and McCabe was recently found "not guilty" by a military jury. One physician testified that Abed has purposefully injured his own lip and then claimed abuse which is apparently in the Al Qaeda playbook. In any event, it has obviously become very difficult to draw the dividing line between deeds of outstanding valor and courage and those which invite criminal prosecution. Many veterans believe that these Navy SEALS should get the highest medal their country can bestow for their service in finally capturing this most-wanted criminal terrorist.

The bad news is that these three SEALS had to undergo a period of severe stress during these trials and will have a cloud of uncertainty hanging over their heads as they return to civilian life. Whatever your individual opinion about the circumstances, all veterans, particularly those who have experienced combat situations, are able to recognize the immediate decisions which must often be made under extreme pressure by our young service people. This is one fact of life all veterans can readily appreciate.

WIL-WIN LODGE, TROUT LAKE, MICHIGAN

In order to remind all Post 46 members to review their wills to see what gifts or bequests they might be able to make to Post 46 or to The American Legion, I hope that many of you will be able to make a trip and visit the newest American Legion property - Wil-Win Lodge, Trout Lake, Michigan. This 600 acre parcel of land and buildings some 20 minutes or so north of the Mackinac Bridge was recently gifted to the Michigan American Legion by Robert W. Considine and a committee has already been formed to determine what improvements need to be made to the property and how it can best be used to serve our veterans. Elmer White and Mike Malley recently met with the committee in Lansing, Michigan, at State headquarters to review the legal issue involved. Legionnaire White has already made a visit to the

property and described it as “drop dead” gorgeous.
