In the last issue of the newsletter, you might remember that there were a few unkind words about our tax system. ## THE "ONLY" POST 46 FUND RAISER OF THE YEAR - "POPPY DAYS"

Again this year, eleven intrepid Post 46 members volunteered to sell poppies to finance the support which Post 46 provides to our hospitalized veterans at the VA Hospital in Ann Arbor. Our poppy sales were conducted at two locations in Ann Arbor - Busch's on Saline-Ann Arbor Road and Kroger on South Maple - from May 16<sup>th</sup> to May 18<sup>th</sup>. Our volunteer salesmen were: Ken Bupp, Dale Burgess, Steve Duncan, Scott Edwards, Frank Fike, Richard Gabourie, Jim Kerley, Michael Malley, Karl Meyer, Oleg Michajlenko and Elmer White. Fortunately, the general public was very generous so that, even with a limited number of volunteers, Post 46 was able to sell a substantial number of poppies. With a sufficient number of volunteers, there is virtually no limit to how many poppies we could sell to benefit our hospitalized veterans; further, the weather in the middle of May is ideal weather to greet the grocery buying public and you can exchange many "war stories" imagined and real with veterans or families of veterans of all ages. Some of our World War II vets took many 2 hour shifts and, of course, "Mr. Volunteer" Dale Burgess, took at least one 4 hour shift. Thanks to all our volunteers - each of you have earned a Post 46 baseball cap if you do not already have one for your charitable efforts.

We hope to see many, many more of you out there next year. As stated earlier, poppy sales is the only fundraiser which Post 46 conducts each year and, although the money collected is important, it is also just as important to remind the public of the sacrifices made by our veterans and some of the history behind them. In fact, our poppy sales volunteers also handed out a brief history regarding the sale of poppies together with a copy of that famous World War I poem, "Flanders Field". A copy of this handout appears below. It resulted, among other things, in the visit by about ten members of a 10th grade social studies class to our Busch's location where poppies were being sold together with some lively discussions and a \$20 donation to our poppy fund:

### **A BRIEF OUTLINE OF THE STORY BEHIND THE POPPY - ANN ARBOR AMERICAN LEGION, POST 46**

On the 11<sup>th</sup> hour of November 11, 1918, an armistice was signed to end World War I, the "war to end all wars". In the United States, we honor this day as Veterans Day. Our Canadian and English cousins name the day as Remembrance Day. Much of the most serious and deadly fighting of World War I took place in an area then described as Flanders, a region between Belgium and France. The soil in this area was so overturned by artillery and other ordnance that it enabled poppies seeds to grow and multiply into fields of color while being surrounded by death and destruction. Their bright red color would forever serve as a vivid reminder of the blood shed during these terrible battles. A Canadian Colonel, John McCrae, wrote a now famous poem entitled "In Flanders Field" in honor of those who died and as a solemn reminder to those who survived:

In Flanders Fields the poppies blow  
Between the crosses, row on row  
That mark our place; and in the sky  
The larks, still bravely singing, fly.  
Scarce heard amid the guns below  
We are the Dead. Short days ago  
We lived, felt dawn, saw sunset glow  
Loved and were loved, and now we lie,  
In Flanders Fields.

Take up our quarrel with the foe  
To you from falling hands we throw  
The torch; be yours to hold it high  
If ye break faith with us who die  
We shall not sleep, though poppies grow  
In Flanders Fields.

Post 46 is named after Erwin Prieskorn, the first Soldier from Washtenaw County to die in World War I.

## BINGO NIGHT AT THE VA HOSPITAL

A Bingo night is scheduled at the VA Hospital on August 16, 2012. If you can join us and help hospitalized veterans with their bingo cards and hand out prizes now in the form of \$2 bills, please let us know. ## AMERICAN LEGION - WILWIN LODGE

For the past two years, this newsletter has informed all Post 46 members that one of the best kept secrets, it seems, is that The American Legion has a veterans' retreat just north of the bridge near Trout Lake where veterans can stay from May through October of each year for a modest charge of \$50 per night and is available to Iraq and Afghanistan veterans at no charge whatever.

As we described last year, Wilwin Lodge sits on some 600 acres of wooded land which was once a major lumbering operation complete with a mill, railroad spur and its own village for workers and lumber buyers. It is now a peaceful retreat deep in the woods of Northern Michigan with five or six of buildings including the main lodge, a "soldier's retreat" and a new assembly hall together with about ten miles of well-maintained trails winding throughout the property. The main lodge is truly a magnificent building which has been carefully updated and maintained to preserve its historic appearance. It can sleep fifteen people in a total of six bedrooms and is complemented by a two story atrium type balcony overlooking dual stone fireplaces at each end.

Planning is underway for a group of some 8 to 10 veterans from the Ann Arbor area to spend a week together at Wilwin this July which will include some members from Post 46. If any of you know of any veterans who have served in Iraq or Afghanistan who would benefit from a vacation at Wilwin Lodge and would appreciate some time staying there while enjoying the peace and tranquility of 600 acres of woods and wildlife, please be sure to let me know. Further, if any Post 46 members would like to spend some time at Wilwin Lodge on their vacation, you are also welcome. Note that travel trailers or RVs can easily be parked on the grounds although at present there are no hook up facilities. So do not hesitate but take full advantage of this holiday opportunity and encourage any Iraq and Afghanistan veterans to do the same.

### **JOB POSTINGS FOR VETS**

For those of you who are on line and for those of you who visit our Post 46 web site at <http://americanlegionann Arbor.org> you will have received or will find on the Post 46 web site a new service which lists job openings in the area for veterans. We hope that this service will soon be available on the Washtenaw County, Department of Veteran Affairs, website and Post 46 will then simply provide a link to that listing. Post 46 has been receiving these job postings courtesy of Pete Bellaire, Marine Corps League, who has a direct pipe line to Sean Sims, State of Michigan, Veterans Service Division, Monroe, MI 734-240-7970. Veterans seeking employment would be well advised to contact Mr. Sims' office directly.

We have a number of Post 46 members who are currently unemployed and, further, many young, newly discharged veterans are encountering significant difficulty in finding employment. This newsletter has previously asked that all members who know of employment opportunities or who know of veterans looking for employment contact Post 46 and exchange this information. There are also a number of job fairs for veteran job seekers. For example, on July 16, 2013, from 9:00 A.M. to 12:00 P.M., there is a job fair at the CVS Regional Learning Center, 5901 Connor Road, Detroit, MI 48213. Information regarding these events and many others are also available from Mr. Sims' office.

During the next five years, it has been reported that one million military service members will return from active duty. There is virtually nothing more disheartening than being a veteran who cannot find work and who is unable to provide for his or her family when their service to their country in uniform is done; however, it can and does happen to any of us, and if you have personally never had the experience, you are truly blessed. All members of Post 46 should be fully aware of those veterans in need of employment. Simply stated, the best way to show appreciation to our service members is to hire them.

### **BASEBALL WRAP UP AND REPORT**

This same time last year, we reported that Commander Steve Duncan has been following our Post 46 baseball team from state to state and from tournament to tournament. By the time you read this newsletter, many of you will have previously received an email inviting you to attend Veterans Appreciation Night at the Eastern Michigan University baseball field. We also hope that many of you will have attended and were honored at the Post 46 baseball team's Veterans Appreciation Night. This game is played at the baseball diamond of Eastern Michigan University on June 25, 2013. Ceremonies began at 6:00 P.M. at which time all Post 46 veterans present were asked to line up on the third base line of the field and, after a singing of the Star Spangled Banner, were presented with Post 46 baseball team dog tags by the Post 46 team players. American League baseball is a time-honored tradition and the baseball team is the most significant activity sponsored by Post 46 on behalf of our youth and our community. Please support the team in any way you can, either financially or by attending games, or both. You will enjoy the competitiveness and company of these fine young men, we guarantee it!

### **POLITICS AND THE MILITARY**

The last two issues of this newsletter have kept you abreast of the trials and tribulations of Lieutenant Colonel Matthew Dooley. We have chosen to follow this particular story because a local Ann Arbor lawyer, Richard Thompson, from the Thomas More Law Center is representing Col. Dooley in his efforts to protect his good name and military career. You will hopefully recall that Col. Dooley was a rising star, according to his officer evaluation reports, until a letter dated October 19, 2011, addressed to a number of high military and federal defense department officials was signed by dozens of Islamic groups alleging that Col. Dooley was, among other things, using bigoted training materials, disparaging the Muslim religion and fostering fear and suspicion of American Muslims among law enforcement and the general public. Less than a year after that letter was sent, Col. Dooley's career was sidetracked when he was relieved from his post as an instructor at the Joint Forces Staff College when he was also denounced by then General Martin Dempsey, Chairman of the Joint Chiefs of Staff.

The course which Col. Dooley had been asked to present was entitled "Perspectives on Islam and Islam Radicalism" and he had received many accolades for the content and research involved in the course. Student evaluations were very favorable but, despite the assurance of the National Defense University that all such courses and presentations would be held in "strict confidence", the contents of the course and its guest lecturers were somehow made public and General Dempsey publically punished Col. Dooley, ordered him to be relieved of his position and that all military training offensive to Islam be scrubbed.

Fighting back as well as he could, Col. Dooley is represented by the Thomas More Law Center. In the opinion of his lawyer, Richard Thompson, Dempsey's actions appear to create a serious threat to America's security. Mr. Thompson quotes the warning of Marine General and former Chairman of the Joint Chief of Staff, Peter Pace, that, if we are to defeat Muslim extremists, it is important to know the nature and motivation of the enemy and that the public punishment of Col. Dooley effectively sabotages our ability to "know the enemy".

When contacted by this newsletter, Richard Thompson stated that Col. Dooley's appeal is still going through military channels because, before being allowed into the federal court system, he must first "exhaust his administrative remedies". Mr. Thompson did not choose to comment any further; however, as all veterans know, when the order comes down from the top, very few people further down the command structure are inclined to risk their careers in questioning it. One such brave officer was Col. Moening of the National Defense University who wrote a memorandum to the Command Review Board as follows:

“I find it disturbing that (Col. Dooley’s) character and flawless reputation have been called into question, and that our academic freedom and non-attribution policies seem to have been disregarded in this case. If the best among us can so readily be cast aside, with disregard for the protections of the Chairman of the Joint Chiefs own Academic Freedom policies at NDU, I am left with great concern for the rest of the military and civilian faculty to perform their duties without fear.”

Richard Thompson has indicated he will provide further information regarding the outcome of the case as soon as he is able to so.

There are dozens of other recent political actions which affect the military which time and space do not allow us to cover. For example, you might have been following the following stories:

**UNIFORMS:** A Congressional subcommittee recently voted to end service-specific camouflage uniforms so that the camouflage uniforms of the various branches would be all alike. Some members thought that the amount of savings to moving to a joint combat uniform was relatively small compared to the morale gained within the services of having separate uniforms.

**STOLEN VALOR:** A new version of the Stolen Valor Act, backed by The American Legion, was enacted on June 3<sup>rd</sup> which now makes it a “federal crime for an individual to fraudulently hold oneself out to be a recipient of any of several specified military decorations or medals with the intent to obtain money, property or other tangible benefit”.

**UNLAWFUL COMMAND INFLUENCE:** A Navy judge recently held that two defendants in military sexual assault cases cannot be punitively discharged, if found guilty, because of “unlawful command influence” derived from comments made by President Obama. The judge ruled that harsh comments made by Obama, as Commander in Chief, would unduly influence any potential sentencing of the defendants if they were to be found guilty.

**FLAG AMENDMENT:** Yet another flag-protection amendment was introduced proposing an amendment to the U.S. Constitution that would give Congress the authority to protect the U.S. flag from desecration. The American Legion has traditionally thrown its support behind this type of legislative action while many have viewed it as a threat to the freedom of speech and are concerned as to how it would be enforced.

**LEGAL SEMINAR - BENEFITS FOR VETERANS:** A local legal education seminar recently offered the following ten tips to lawyers for getting benefits for veterans and their families: 1. Ask every client about military service in the family 2. Get VA accreditation 3. Stay on the right side of restrictions 4. Non-service connected disabilities may be covered. 5. Look into health care benefits. 6. Look into VA nursing homes. 7. Know about the \$40,000/\$80,000 asset limit myth. 8. Deduct unreimbursed medical expenses if income limits loom. 9. Set an early effective date for pension benefits. 10. Know the effect of planning for VA eligibility on Medicaid eligibility.

**ANN ARBOR VA HOSPITAL - MENTAL HEALTH SERVICES:** The Veterans Affairs Office announced recently that it has met its nationwide goal of hiring 1,600 mental health workers. For our local VA Hospital in Ann Arbor, this has meant the addition of eight new employees to the staff – a compensation and pension psychologist and seven social workers.

**VALUABLE INFORMATION ON THE INTERNET:** For those of you are connected to the internet, we hope that you regularly visit some of those sites which are dedicated to providing information about and to the military and its veterans. The “main stream” press often ignores or gives little coverage to events or items directly affecting the military. There are literally hundreds of such websites and our Post 46 website links you to some of them.
